MINUTES

I. Welcome, Flag Ceremony, and Call to Order

Board Chair Debra Harden welcomed delegates and guests to the 2020 Annual Meeting of Girl Scouts of Historic Georgia (GSHG). Girl Scout Senior Adelyn Walls, Troop #60642, served as Mistress of Ceremony.

Girls from Girl Scouts of Historic Georgia's Troops 30460, 50105, 50141, and 60206 served as Honor Guard and led the delegation in the flag ceremony, the Pledge of Allegiance, and the Girl Scout Promise.

Special guests were recognized.

There was an official quorum with 45 voting members in attendance, representing all six regions. The meeting was called to order at 12:30pm.

Board Secretary Jeff Hewitt reviewed voting criteria and presented the 2019 Annual Meeting minutes for approval on behalf of the Readers for the 2019 Annual Meeting. The 2019 Annual Meeting minutes were approved.

II. Chair and CEO Council Report

Debra Harden, Board Chair/Sue Else, CEO

Board Chair Debra Harden gave a report on the state of the council. Chair Harden then introduced guest speaker Karen Ribble, Augusta University Cyber Institute, to the podium.

Karen spoke about STEM and its importance in the work force, STEM programs, how to get more girls interested in STEM, and gave a brief history of cyber technology.

GSHG CEO Sue Else thanked Karen for her remarks and completed the report on the state of the council. She then called Betsy Connell, Director of Program, to the podium.

III. Acknowledgement of 2019 Gold Award Recipients Betsy Connell, Director of Program

Betsy Connell, GSHG Director of Program, reviewed the requirements of the Gold Award. Betsy explained that the Girl Scout Gold Award recognizes the work of Girl Scout Seniors and Ambassadors who have achieved outstanding accomplishments in the areas of leadership, community service, career planning and personal development. She then shared a video from GSUSA about the Gold Award.

During lunch, a video was shown recognizing the 2019 GSHG Gold Award recipients and their projects. Many of the girls were unable to attend today's meeting because they were away at college.

Betsy then called Gold Award Recipient Jaiden Thompson to the podium. Jaiden received her Gold Award in May. Jaiden was invited to attend the State of the Union address in Washington D.C. as a guest of Representative Buddy Collins. Jaiden discussed the details and outcomes of her project which was geared for students in need of hygiene items and school supplies.

IV. Treasurer's Report

Laura Toms, Board Treasurer/Finance Committee Chair

Laura Toms presented the Treasurer's Report and the current financial status of Girl Scouts of Historic Georgia. The financial report was included in the 2018-2019 Annual Report. The Total Operating Revenue and Support was \$5,767,617 in comparison to \$5,522,322 in the 2017-2018 year. The council ended the year in the black with a surplus of \$53,231. The council's audit was recently completed with an unqualified opinion. This is the best opinion a nonprofit can receive. The Treasurer's Report was adopted by consensus.

V. Board Nominating Committee Report Jeff Hewitt, Board Member

Before presenting the slate of nominees, the criteria for those eligible to vote was reviewed: current board members, Board Development Committee members, and council delegates.

The slate of nominees for the Board of Directors as well as the National Council Delegates who will represent the council at the GSUSA National Convention in October 2020 was presented. 
VII. Closing Ceremony

She retired from the Georgia General Assembly in 2016. Ms. Randall is an alumnus of Leadership Macon (1998) and Leadership Georgia (2004). She is also an active member of Democratic Party of Georgia, Healthcare Businesswomen's Association, Georgia Women & The Ones Who Stand with Us, Macon Chapter of the LINKS, Incorporated, and Alpha Kappa Alpha Sorority, Incorporated. COUNCIL SERVICE FEE PROPOSAL

Proposal:

Beginning the next membership year, the GSHG board is proposing that we implement a \$5.00 council service fee to be used to provide financial support to girl members. It will be added to the membership registration form and will only apply to girl members.

Background Information:

Several years ago GSUSA authorized councils to add a council service fee to the annual membership fee. Each council's board has the authority to determine how the funds will be used and the amount of the fee.

The council service fee was approved the same year our membership fees went from \$15 to \$25. Our board discussed implementing the fee then and has considered it many times over the years, but the timing never seemed right. However, this year is unlike any other, and the board has determined it is necessary to now add a small council service fee to ensure we can continue providing support for the girls we serve.

Rationale:

Over the past several years the council has seen a dramatic increase in requests for assistance. In fact, in just two years financial assistance increased 36%.

- o In 2018-19, we spent 190K in financial assistance
- o In 2019-20, we spent 226K in financial assistance

Financial assistance is primarily used for membership fees, which go directly to GUSUSA. However, the funds are also used to help with:

- o Uniforms and program materials
- Camperships
- Program fees
- Beyond the Troop travel

Frequently Asked Questions:

In our efforts to assess the potential impact to Girl Scouts and their families, members of the leadership team called several service area leaders individually and met with the service area teams. Here are some of the frequently asked questions and concerns:

Are other councils charging a service fee?

- Currently 48 councils have a council service fee (about 44% of councils nationally)
- Service fees range from \$3 \$20, with 39 councils at between \$10-15 per girl.

Aren't some girls covered by their insurance companies?

 Yes, there are girls who qualify for coverage with their health insurance company. Most of those funds are for membership fees which go directly to our national organization.

What about girls who receive financial aid who cannot pay the fee?

• We will continue to process those applications internally and those fees will be paid by the council and go back in the Financial Assistance funds pool.

Will the council service fees completely cover the costs of financial aid?

 No. Using the 2020 year-end girl membership numbers, it would fund about 25% of the expense.

We cover the girls in our service area. Why should we support the council service fee?

While some Service Areas (SAs) have the funding necessary to provide financial assistance to girls in their area, others do not. Additionally, some areas do not have service area teams. Our goal is to ensure every girl in our council has the opportunity to have a full experience, irrespective of her family circumstances. Remember, the Girl Scout Law instructs us to be a sister to every Girl Scout. While sisters do not always agree, we do look out for each other.

Will we continue to have the Friends and Family Campaign for donations?

 Yes, we will still have the Friends and Family campaign and those donations are voluntary. We know there are still many donors who will want to continue supporting the mission.

We need your help:

While the board has the authority to authorize the council service fee, they have decided to include the council delegates in this important decision. We are asking council delegates to adopt this proposal to secure the funds necessary to help offset the rising need for financial assistance.

We know that \$5 is an additional cost and may mean an added \$10 or \$15 for families with several Girl Scouts. However, we believe this is a wise investment and will help other girls in our community to have access to all the wonderful things our program offers.



Statement of Financial Position As of: 9/30/20

In 2019-20 the Girl Scouts of Historic Georgia partnered with Qbix, an outside accounting firm, to further maximize the council's resources. Staff members work closely with Qbix to monitor income and expenses, as well as ensure accurate financial information is provided to our stakeholders.

There are a few items of significance in fiscal 2020, most notably impact of COVID 19. In March the council moved to virtual programing and fund raisers. GSHG did receive a PPP loan. Finally, the council sold the Columbus office on 13th and is planning to renovate the Little House in Columbus with program space as well as office space. With the help of staff who worked diligently to control expenses, the council ended the year with a surplus of \$3432 after depreciation.

Overall, there is good news and positive progress to report for the 2019-20 fiscal year.
